This class action lawsuit was started over 15 years ago and principally said that Visa and MasterCard violated the law because they set interchange fees. It went to trial in 2018 and in January of 2019, Visa and MasterCard made an offer to settle with the plaintiffs and the court approved.

The court ratified the Settlement for \$5.54 Billion on December 13, 2019.

All persons, businesses, and other entities that have accepted any Visa-Branded Cards and/or MasterCard Branded Cards in the United States, **for the 15-year period January 1, 2004 - January 25, 2019**. This includes every business that a claimant may have owned or controlled that had individual EIN's for ANY period through this 15-year timeframe.

It is important to know that every merchant can file their claim with the Claims Administrator without using the services of an attorney or a third-party claiming service such as CCS. The official website is www.paymentcardsettlement.com.
